## Petition Update

#### South Africans rally to change the legal status of non-humans

More than 51 000 South Africans so far have signed our Petition to have animals legally reclassified as 'Sentient Beings'. A huge THANK YOU to every single person who has dedicated so much time and effort to collecting signatures.

The response has been wonderful. Until we launched this Petition, most people had no idea that animals are legally regarded as 'moveable property' or 'chattel' — just like slaves used to be legally regarded as 'chattel', just like a piece of furniture is chattel. In fact, many people have said they're 'flabberghasted' to think that, at the year 2000, such an archaic perception of animals can still be on our statute books. Ordinary people have long since known that animals have a robust ability to enjoy life as well as an ability to suffer, equal to that of mankind. It's time the law caught up with reality.

Giving animals their rightful legal

status as 'sentient beings' literally meaning that they can 'feel' and 'perceive', unlike inanimate objects such as furniture, is an absolute prerequisite to getting meaningful changes made in existing animal legislation and regulations.

### Expert on link between animal cruelty and human violence to visit SA

American **Phil Arkow**, world renowned expert on the link between animal cruelty and human violence, is to arrive in South Africa on February 14 for a week-long national lecture/seminar/workshop tour, at the invitation of **Animal Voice.** 

Chairman of the Child and Animal Abuse Prevention Project of the Latham Foundation in the USA, Phil Arkow recently co-authored the definitive text book on how human violence almost always has its roots in animal cruelty. Called "Child Abuse, Domestic Violence and Animal Abuse: Linking the Circles of Compassion for Prevention and Intervention", the book is the culmination of 26 years of research, conducted in close collaboration with the FBI.

Says Arkow: "Animal abuse does not occur in a vacuum."

Says Animal Voice Founder, Louise van der Merwe: "We are deeply indebted and profoundly grateful to the Matthew Eyton Animal Welfare Trust in the UK for enabling us to extend an invitation to Phil Arkow. He has accepted

May history look back on the time in which we live now, as the turning point for the animals, the beginning of an era when at last, mankind extended ethical and moral consideration to all life.



Ruth Harrison is close to 80 years old now, but more than three decades ago, this brave British woman dared to challenge the prevailing wisdom of her time by suggesting that agriculture had gone berserk in its attempts to turn animals into machines.

Her book, Animal Machines, published in 1964, was written at a time when the post-World War II world had already embarked, with religious fervour, on its obsessive quest for cheap food and maximum profits. The industrial revolution, automation and technology had finally hit the countryside too. Removed from public view and packed into vast sheds, animals became "units of production" to be "grown" and "harvested". Their welfare was measured in terms of "performance".

One of the most glaring of cruelties was the battery cage for laying hens. Led by former dairy farmer, Peter Roberts, Compassion in World Farming soon opened its doors, as did Chickens' Lib (now Farm Animal Welfare Network), founded by Clare Druce. The fight was on. This year, those campaigners who dedicated so much of their lives to fighting the nightmare world of battery cages, experienced the sweet taste of victory. What they had known intuitively, had, at last, been proven. Battery cages for laying hens are cruel and inhumane. Finally the European Parliament succumbed and, on June 15, 1999, it announced the total abolition of traditional battery cages. There will be a12-year phase-out period.

Said Peter Roberts recently: "Our start was traumatic indeed, with ridicule heaped on us from all sides. It came from farmers, vets and not least from the Ministry of Agriculture. But there is nothing more powerful than an idea whose time has come. Compassion in World Farming was, and is, such an idea... Compassion involves a change in consciousness, so that we come to see animals as individuals, each developing its own character, rather than as herds or flocks."

Commented **Clare Druce**, "Given the massive size of the egg industry and the strength of the forces lined up against the welfare movement, the ban represents a wonderful victory for compassion."

#### British author pleads for end to "Animal Apartheid"

British author **Audrey Eyton** who worked in South Africa as a journalist during the Soweto uprising, in the 70's, comments:

"Working on a newspaper in South Africa in 1976, I looked across the sea to Nelson Mandela's prison island, thought of his 'army', just black school children throwing stones against the heavily armed might of white forces, and wept at the hopelessness of it all. When I came home I gradually became involved in fighting 'animal apartheid'. the system in which we consign animals to a horrific life of hard slatted floors and close confinement between cage or concrete walls... When South Africa's apartheid system was still in place, I heard a lecture by Father Trevor Huddleston which ended movingly with this plea: "I'm an old man. Please help fight apartheid. I so long to see the end of this terrible system in my own lifetime." I am getting on myself now. I often think of Father Huddleston and sometimes I dare to hope that I will see the end of apartheid for animals in my own lifetime. Like him, I say: Please help.



Unlike their British and European counterparts, there is still no light at the end of the long, dark tunnel for South Africa's 15 million laying hens which remain incarcerated in batteries across the country. Yet, for every dozen-a-week family which switches to free-range eggs, two more hens go onto "range" instead of into the battery. Only you, the consumer, can buy laying hens their freedom.



On the eve of the Year 2000, we look back at the milestones we have passed in the long walk leading towards justice for animals.

- Animals are legally recognised as 'sentient beings' in the EU.
- Sow stalls: banned in the UK. Still legal in SA.
- Tethers for breeding pigs: banned in South Africa and UK.
- 1000 UK pig farms agree to ban the farrowing crate for pigs to comply w i t h t h e R S P C A 's "Freedom Foods" quality assurance scheme. Farrowing crates still legal in SA.
- Veal crates: banned in the UK. Still legal in SA.
- Traditional battery cages: banned in the EU with a 12-year phase-out period. Still legal in SA.
- Legislatures across the USA upgrade animal cruelty crimes from "misdemeanors" to "felonies" and animal law becomes a new branch of legal study in that country. Says one such lawyer: "My commitment is that I don't eat my clients."
- Harvard Law School offers an animal rights law course for the first time.
- Peter Singer, father of the animal rights movement, is appointed to the prestigious post of De Camp Professor at Princeton University's Centre for Human Values, USA.
- South Africa's own world acclaimed novelist and literary critic, J.M. Coetzee, writes The Lives of Animals, a novel which sympathetically examines the rights of animals. The book is published by The University Center for Human Values at Princeton University.
- Strenuous lobbying begins at the millennium round of the World Trade Organisation in Seattle, for a reform of WTO Free Trade rules so that countries which have achieved higher welfare standards for animals, can prevent the importation of competing products produced by countries with lower welfare standards.

- Swaziland's King Mswati III reminds all outlets selling pellet guns, pellets and gintraps, that all birds are 'royal game' in Swaziland and that it is a non-bailable offence to hunt, kill or molest them.
- Leghold or gin traps are banned in 89 countries around the world. South Afrea is not one of them.
- Live plucking of ostriches before slaughter in SA is banned.
- Great Britain bans the testing of cosmetics (including ingredients), alcohol and tobacco on living animals. Nevertheless, 2 659 662 scientific procedures were carried out on living animals in that country in 1998. No figure is available for SA where transparency and accountability laws for vivisection are non-existent.
- The Great Ape Project (GAP) whose mission is to attain a United Nations Declaration of Rights for the Great Apes, gains momentum in political arenas in both the USA and New Zealand. GAP reports that tens of thousands of signatures supporting GAP are pouring in from around the world. (Sign your name on: http://host.envirolink.org/gap/gapde conline.html)
- Poland bans force-feeding of geese and ducks for the production of pâté de foie gras.
- The Indian Constitution provides

that 'the people of India have a moral obligation to prevent animal suffering.' The SA Constitution, despite being hailed as one of the most progressive in the world, remains devoid of consideration towards South Africa's non-humans.
